# EPC payment schemes and VOP, numbers<sup>1</sup> and expectations



- SCT Inst scheme compliant PSPs
  - Euro Area: **2,673**
  - SEPA: 2,749
- SCT scheme compliant PSPs
  - Euro Area: **2,966**
  - SEPA: 3,523
- SCT (Inst) scheme participants that opted out from VOP Scheme at SEPA level: ar. 210

### VOP participants

- Actuals: 355 (VOP applicants with status "Accepted")
- Expected<sup>2</sup> as of 5 October 2025: **2.700 3.300**

### RVMs

- Actuals: 45 (RVMs with "ongoing" qualification status)
- Expected<sup>2</sup>: up to 60 (out of the 64 currently listed on EPC Web site)

## EPC monitoring of 2025 payment schemes and VOP roll-out





### Scope:

- Light coordination of activities incl. time plan
- Consolidate reporting to EPC decision-taking bodies and Overseer

### Stream 1 Payment schemes

#### Scope:

- Monitor the roll-out of the 5 EPC payment schemes
- Provide an early alert in case of late delivery
- Reporting to EPC decision-taking bodies and to Overseer

## Stream 2 Verification Of Payee (VOP) scheme

#### Scope:

- Monitor the roll-out of the VOP scheme
- Setup a smart process for adherence to VOP scheme and monitor it
- Reporting to to EPC decisiontaking bodies

### Stream 3 VOP interoperability

### Scope:

- Refine strategy to mitigate interoperability issue for VOP scheme
- In charge of VOP API sandbox, test catalogue, self-certification process etc
- Define duties of Routing and Verification mechanisms (RVMs) and create a «RVM forum»
- Reporting to EPC decision-taking bodies


## Stream 4 EPC Directory Service (EDS) Project

#### Scope:

- Finalize EDS business/ functional specs and contract with the EDS operator
- Manage the successful deployment of EDS
- Prepare handover to service management phase
- Reporting to EPC decisiontaking bodies

# EPC monitoring of 2025 payment schemes roll-out: CSMs (2/2)



- The overview below summarizes the status of responses collected from the CSMs offering services to one or just a few national PSP communities
- The numbers do not include the pan-European CSMs as they issued their specifications end February and mid-March respectively
- Impact of later than expected publication of stable specifications on EPC payment scheme participants and other technical service providers (e.g., software vendors supporting PSPs) still to be determined

Number of CSMs* operating at national level or just a few countries which reported:	By end of March	In the course of April	By end of April 2025 at the latest
Publication of stable specifications for the batch schemes:	For SCT: 8	For SCT: 5	For SCT: 2


# **EPC monitoring of 2025 payment schemes roll-out: PSPs**



- The EPC will regularly request written status reports about the implementation progress of the 2025 EPC payment scheme rulebooks at the level of the **national PSP communities**
- The next calls for PSP community input are set on **9 May**, **6 June**, **18 July**, **8 August**, **5 and 17 September** any input relevant for CSMs will be shared in the next EPC-CSM calls
- The EPC Payment Scheme Management Board (**PSMB**) meets on **27 June**, **22 August** and **9 September** to discuss the implementation status and to **validate the go-live date of 5 October 2025**
- Each 2025 **PSMB Bulletin** will inform the EPC payment scheme participants about the latest implementation progress of the 2025 EPC payment scheme rulebooks, and about any issue that would be of concern to all EPC payment scheme participants





### **Conclusions**



- Payment scheme roll-out: late start of UAT and end-to-end tests leave limited contingency
- VOP roll-out very challenging, but on track so far
- The EPC is:
  - Investigating payment schemes VOP cross-dependencies
  - Elaborating a plan B / plan C
- PSPs need to have a plan for the October 2025 go-live, to mitigate undesired
   VOP effects

### VOP roll-out challenge: many «first times»...



- 1st time for an EPC scheme based on APIs with a central directory and expected massive adoption
- 1st time an EPC scheme has to scale up from 0 to 3.000 PSPs in less than 2 years
  - 18 months since first VOP Rulebook's draft
  - 12 montsh since final VOP Rulebook version
  - 6 months since the start of Adherence
- 1st time the EPC is playing an IT operating role with EDS (EPC Directory Service)
- 1st time the EPC is playing an active role to facilitate Interoperability (self-certification based on ART platform)
- 1st time the EPC is developing a contractual relationship with infrastructure players
  (qualification process for Routing and/or Verification Mechanisms RVMs)
